Thank you for being a valued FEC family.

I am writing you today to let you know that we have made the difficult decision to close the JCC FEC temporarily, effective Monday, March 16-April 6. As you are aware, we have always looked to the Albuquerque Public schools for guidance on school closures. At this time of uncertainty regarding the spread of Covid-19 (Coronavirus) in our community, we have decided to follow the lead of APS and the Governor's recommendations and have chosen to close the FEC.

Our first priority has been and will always be to keep the children and families of the FEC healthy and safe. Therefore, given the rapid spread in other states and countries and the potential severity of the Covid-19 virus, we felt that this difficult decision was necessary.

We will continue to monitor the status of Covid-19 cases in our area and adhere to the recommendations provided by our Governor, the CDC, the World Health Organization.

Please let us know if you and/or your child have been exposed to the Covid-19 virus or has received a positive test result for the virus. Our aim is to keep everyone in our community healthy, and families are the first line of prevention. Symptoms of the Coronavirus are fever, cough, and shortness of breath.

We appreciate your financial investment in the care of your children. Your tuition along with other funding from the JCC covers FEC expenses for the entire budget year. At this point in time, we ask for your understanding that we cannot refund tuition for this unexpected emergency situation.

We hope that we can welcome your wonderful children back to the FEC on April 6. We will contact you immediately if there is an extension of the school closure.

We thank you for your continued support of the FEC.
